The Law Amending the Union Budget Law, 2016 (The Pyidaungsu Hluttaw Law No. 37, 2016) The 13th Waning of Wagaung, 1378 M.E. (31th August, 2016)

The Pyidaungsu Hluttaw hereby enacts this Law.

- 1. This Law shall be called the Law Amending the Union Budget Law, 2016.
- 2. The expression "Ministry of Finance" contained in the Union Budget Law, 2016 shall be substituted with the expression "Ministry of Planning and Finance".
- 3. The expression "no more than kyats forty-five hundred thousand million" contained in section 13 of the Union Budget Law, 2016 shall be substituted by the expression "no more than kyats fifty hundred thousand million".
- 4. In subsection (a) of section 27 of the Union Budget Law, 2016:
 - (a) Clause (ii) shall be substituted as follows:
 - "(2) Being the expenditure permitted by the approval of Pyidaungsu Hluttaw upon the recommendation of the Union Government if it is a special case in which the expenditure must be incurred within the financial year."
 - (b) Clause (iii) shall be deleted.
- 5. The schedules (2), (3), (4), (5), (6), (7), (8), (9), (10) and (14) contained in the Union Budget Law, 2016 shall be substituted by the respective schedules contained in this Law.
