Terms and Conditions of Representative Office Registration Certificate (IBRB / R.O (R) - 01/2019)

- 1. The Insurance Business Regulatory Board, in accord with provisions of the Insurance Business Law, the Insurance Business Rules, and Regulations, By-laws, Orders, Directives, Guidelines and Notifications, issued this Representative Office Registration Certificate to carry on representative offices' activities thereunder.
- 2. The Registration Certificate holder may carry on the following operations
 - (a) Establishment of representative office;
 - (b) Market survey;
 - (c) Collaboration project on insurance with any other insurer;
- 3. A representative office and its employees shall not enter into any agreement or contract with any legal or natural persons, which might generate an income to the representative office or the foreign insurance institution it represents and shall not be involved in business activities of any kind. Educational activities including technical assistance and capacity building do not require a registration certificate for a representative office, but require approval from the Insurance Business Regulatory Board.
- 4. A representative office shall submit financial statement and an annual report of its head office and / or the report of its performance (or) work to the FRD within three months after the end of the fiscal year.
- If any following major event occurs in an insurance institution that has maintained a representative office in Myanmar, the representative office shall, within 10 days after the occurrence of the event, submit a written report to FRD.
 - (a) A change in its articles of association, registered capital, and registered business address;
 - (b) Division or merger or change of top management;
 - (c) Serious losses resulted in business operation;
 - (d) Penalties imposed for violations of laws and regulations;
 - (e) Major regulatory actions taken against it by the regulatory authorities of its home country or territory;
 - (f) Other matters which may seriously disrupt business operation of the foreign insurance institution.
- 6. A representative office authorized prior to the effective date of this order shall be deemed as a holder of the Registration Certificate under this order and shall comply with this order within 3 months of the effective date of this order.
- 7. Who desires to establish a representative office in Myanmar shall apply to the Authority for Registration Certificate and complete the form that can be downloaded in webpage (www.frd.gov.mm).
